TERMS AND CONDITIONS

The Buyer purchases from the Seller a breeding card for the stallion GINKO DU ROUET under the following conditions:

Reservation: **€316.50** incl. VAT (including 5.5% VAT) is due with signed contract

Balance: **€949.50** incl. VAT (including 5.5 % VAT) foal alive at 48h

- The Buyer undertakes to notify the Seller, by e-mail in the autumn, of the result of the covering and the planned foaling date. He then undertakes to pay the balance invoice within 8 days of foaling or to officially notify the Seller if the mare has not given birth to a viable foal within 48h.

- The seller offers the buyer a live foal guarantee, In the event that a live foal was not obtained, a foal passes within 48 hours of birth, or that the mare absorbs or aborted the foal.

Mare Owner is required to give rhino vaccinations according to manufacturer's specification during the pregnancy of the mare.

Mare must be kept at an acceptable weight and wormed regularly.

- Any delay in payment will result in the non-delivery of the covering certificate.

2- The stud fee includes the price of the doses (3 doses i.e. 12 straws) and their delivery in France.

The shipping costs for abroad will be extra charged to the mare-owner.

3- ICSI use is forbidden.

4- The mare may be inseminated several times, however the seller reserves the right to stop supplying straws for mares that have been inseminated on at least 3 heats or are not pregnant on July 1st.

5- The reservation of the card is effective upon return of the signed contract with payment of the reservation deposit. The signatory of the present contract is legally liable for payment of the balance of the service, even in the event of resale of the mare.

6- Unused doses remain the property of the seller. At the end of each season, the mare's inseminator or the customer undertakes to return any unused straws to EUROGEN or to the Haras de Bossy.
